DCM: DCM report from spring service conference Area 24 virtual conference committee met. The committee met to broadly discuss the essential roles of a virtual conference, each committee member has had experience with the planning and execution of virtual conferences. A rough guideline has been created and is in the process of being edited by each committee member. We anticipate a more finalized version of this guideline by the March Area Business meeting. District 7 was nominated to host fall conference 2021. No other districts stood to host. Delegate Report: Mary Ann G. (Summary). On Saturday we began early, and discussion of the agenda items were separated into breakout rooms. My breakout room was Grapevine/La Vina and Trustees. The Grapevine/La Vina discussion focused on Item D. Review progress report on development of an Instagram account and Item F. Review suggested gender-neutral language options for the changes to the AA preamble. The Trustees discussion focused on Item F. Review the Statement of Concern and motion to censure the General Service Board. The Trustees committee has met twice in preparation for the General Service Conference. There are 8 vacancies which equates to 53 resumes for the committee to review. We have already been individually reviewing and sharing any administrative errors or missing information to try and reduce our workload once at the conference. We plan to meet again in 2 weeks. On 29 Mar I will attend the West Central Regional Trustee Delegate Orientation. Alternate Delegate Report: Julie S. (Summary) I meet monthly with “NAAD” (North America Alternate Delegates) groups which are Alternate Delegates from the US and Canada. on the first of every month. Recently our discussion has been centered on how each Area approaches disseminating and discussing the Conference Agenda Items. My general take-away is: that while it always feels like a lot to get through in 3 months, I believe Area 24 has, and continues to do an excellent job of this. I also was privileged to attend the West Central Regional Conference, attending the Agenda and Trustee breakout sessions, and all the summary sessions. The General Service Office database (Fellowship Connection) is fully functional. Group and District, and Area changes are entered into this system. This signals the GSO of new positions so they can send packets, workbooks, and other needed material if applicable. I do have to have a personal email in order to look up or enter a person into the database, so please assure that this information is included. If the position has an email (i.e: Area24.altdelegate@aa-iowa.org) this will be used in the Directory as desired, but we do not want to tie the position email to a person. The person email will only be used in the FC database which is not public. Additionally, please assure you provide physical addresses as well in order to receive mailings. The Area 24 Directory is a separate document maintained for the use of Area members to conveniently look up Area and District information. The most current Directory will always be available in the Area 24 shared Dropbox folder. It is difficult, if not impossible right now to maintain an accurate Directory and Meeting guide with the many groups utilizing a virtual or hybrid format for their meetings or temporarily changing locations. Our hopes are that most groups stabilize this year. If you think the group will continue in temporary quarters for a longer period of time, you may send me a notice or complete a group change form indicating temporary location. Then complete or send notice of change when the group returns to its previous or original location. Each group is assigned a Group ID number. If your group was in existence before October of 2019, the old FNV group number is still valid and

On April 10, 1939, 4,650 copies of the Big Book, Alcoholics Anonymous, became available for distribution. Cornwall Press would deliver copies to Works Publishing Company, with an office on William Street in Newark, New Jersey. The grand bill for the print run was \$1,783.00! Copies were also delivered directly to “friends” of the Fellowship, including associates of John D. Rockefeller who aided significantly in the publishing venture. Today, over 40 million copies have been sold! I look forward in sharing with you each month the history of Alcoholics Anonymous. In Love and Service Sheryl F.

There was a settlement for the cancellation of the International Convention last year which actually covered all monies assumed to be lost, also, GSO has had record breaking contributions for the last part in 2020 which has prevented them from dipping into the prudent reserve. 2021 Big Book Conference Theme is “164 & Much More.” Area had 8 positions OPEN, 6 of them being Alternate, however, only one position was filled and that was an Alt CPC. 
