**DCM:** Greeting's district 9, I attended the area 24 business meetings in Marshalltown august 15th. Here are some of the highlights- the west central regional forum will be September 10-13th. (I will be attending periodically throughout the weekend). Delegate highlights: - The West Central Regional Delegates Meetings have been a wealth of information from the West Central Regional Trustee and the other Delegates across our region. - GSO announced the selection of the new AA Grapevine publisher Chris C. Chris has been the interim Publisher over the last 8 months. He was chosen from a competitive pool of 20 candidates. -Change to preamble from men and woman to people in the preamble was an advisory action from the 71st General Service Conference not from the Grapevine itself. - GSO is working to revise the Corrections workbook which was also an advisory action from the conference. There were approximately 60 changes to the workbook, and 20 changes to the kit. Alt delegate highlights: - In July, Alternate Delegates of the West Central Region (7 states and 8 Areas including lowa) presented on their respective Areas, providing history, strengths, and opportunities. - Adding and updating information regarding districts and groups. - As of 8/1/21. Area 24 currently had 658 active groups listed. Many groups that were once online are now back in person or with a hybrid option. - Just as a quick point of clarity...if one completes the form for New Groups or Group Changes via aa.org (rather than aa-iowa.org) we at the Area level unfortunately will not get looped in on that information. The way to assure that everyone (District, Area, and GSO) gets information on all additions or changes is to go through the Area Registrar (area 24 alt delegate Julie Shaw). - At my last audit, everyone who has submitted information has been entered into the Fellowship Connection system. Fall 2021 conference report- The dates are October 8th - 10th. The conference will be held at the Embassy Suites downtown Des Moines. Flyers are on aa-iowa.org. Al anon has decided to make this a hybrid conference and is requesting that we arrange for equipment for them. Al anon has agreed that those joining via zoom will pay a registration fee. We will set this option up on our cheddar.com registration process. 20 people join via zoom. It is undecided at this time if a luncheon/speaker fee will be charged for a hybrid luncheon or if a hybrid luncheon will even be an option as that will require additional equipment. They are still requesting space for 150 people per conference guidelines. They have also let me know that moving forward, they will offer a hybrid option for conferences. Please note that the minimum for the conference did increase to \$6500 since the last time we met. During the walk through our Al anon committee members requested additional space. I met with the finance committee, and we decided to reserve the entire space. This increased the minimum to \$6500. I am concerned about our finances as registration is coming in so slow. As of August 4th, we had 15 online registrations and our treasurer received \$632 in registrations. That said, our committee is working hard to get the word out to register. Archives: Greetings from Archives, Trivia Question: What year was the responsibility statement created? Answer: 1965 By Al S. 1947 First stirrings in England Though the first official A.A. group in England won't be formed until 1948, the ball gets rolling when a visiting American woman, Grace O., writes to five Londoners who are in touch with the Alcoholic Foundation and schedules a meeting at the Dorchester Hotel (right) for March 31, 1947. The eight attendees include two A.A. members from North America: an A.A. from Hollywood, California, whose acquaintance she had made on the voyage across the Atlantic, and "Canadian Bob," whom Grace had met in a London restaurant and who will figure large in A.A.'s growth. Meetings will continue in restaurants and residences, among them the home of Canadian Bob. 1950 A.A.'s first International Convention in July 1950, Alcoholics Anonymous' 15th anniversary is marked with an international convention in Cleveland, with some 3,000 people in attendance. One of the most significant events is the adoption of the Twelve Traditions. The convention, held at the Cleveland Public Auditorium (right), also features the last public message to the Fellowship by Dr. Bob, who stresses, in his brief remarks, kindness and "keeping it simple." 
