Quick look at the 10th Tradition

When we practice the 12 steps of A.A. as a way of life, we recover from a hopeless state of mind & body; when we incorporate the principles of the 12 traditions, we ensure the health and unity of our A.A. groups.

<u>Tradition TEN</u> short form: Alcoholics Anonymous has no opinion on outside issues; hence the AA name ought never be drawn into public controversy.

<u>Tradition TEN</u> <u>long form</u>: No A.A. group or member should ever, in such a way as to implicate A.A., express any opinion on outside controversial issues - particularly those of politics, alcohol reform, or sectarian religion. The Alcoholics Anonymous groups oppose no one. Concerning such matters they can express no views whatever.

Twelve Steps and Twelve Traditions, commonly called the "12 & 12", says: "As by some deep instinct, we A.A.'s have known from the very beginning that we must never, no matter what the provocation, publicly take sides in any fight, even a worthy one. All history affords us the spectacle of striving nations and groups finally torn asunder because they were designed for, or tempted into, controversy. Others fell apart because of sheer self-righteousness while trying to enforce upon the rest of mankind some millennium of their own specification. In our own times, we have seen millions die in political and economic wars often spurred by religious and racial difference. We live in the imminent possibility of a fresh holocaust to determine how men shall be governed, and how the products of nature and toil shall be divided among them. That is the spiritual climate in which A.A. was born, and by God's grace has nevertheless flourished."

As A.A. members, we share our experience, strength, and hope in meetings as it relates to our alcoholism, and avoid talking about our political or religious leanings, our opinion on certain medications or doctors. By not taking an individual stand and expressing our opinions on controversial issues, we not only avoid giving the wrong impression that the group shares that opinion, but we avoid tempting the next person to share theirs which may oppose yours, etc...

TRADITIONS CHECKLIST FROM THE AA GRAPEVINE¹

Tradition Ten: Alcoholics Anonymous has no opinion on outside issues; hence the AA name ought never be drawn into public controversy.

- 1. Do I ever give the impression that there really is an "AA opinion" on Antabuse? Tranquilizers? Doctors? Psychiatrists? Churches? Hospitals? Jails? Alcohol? The federal or state government? Legalizing marijuana? Vitamins? Al-Anon? Alateen?
- 2. Can I honestly share my own personal experience concerning any of those without giving the impression I am stating the "AA opinion"?
- 3. What in AA history gave rise to our Tenth Tradition?
- 4. Have I had a similar experience in my own AA life?
- 5. What would AA be without this Tradition? Where would I be?
- 6. Do I breach this or any of its supporting Traditions in subtle, perhaps unconscious, ways?
- 7. How can I manifest the spirit of this Tradition in my personal life outside AA? Inside AA?

For anyone wanting to understand the traditions better, I encourage you to grab a few A.A. friends and together read the <u>Twelve Steps and Twelve Traditions</u>! Get a copy of the <u>Twelve Traditions Illustrated</u> pamphlet and the <u>Traditions Checklist from the AA</u> <u>Grapevine</u> too (these are available at our local Illowa Intergroup Office; for convenience they are linked here to aa.org). Using these 3 together can help broaden our understanding of why they are so important still today, and zone in on how we can be better at practicing the principles in our groups, and even our jobs and homes.
